PLEASE USE THE FOLLOWING GUIDELINES FOR THE ENJOYMENT AND CONSIDERATION OF ALL!

All roads are one-way except the main entrance. The speed limit is 5 MPH and is strictly enforced. *Please keep all vehicles and campers off the grass areas*. We reserve the right to evict any person or person(s), who in our opinion is violating the guidelines, vandalizing, creating a disturbance, etc. **WITHOUT ANY REFUNDS.**

General

- Check-in time is 1:00 PM Check-out time is 11:00 AM.
- Quiet Time is from 10:00 PM to 8:00 AM. All children must be back At their campsite by 9:00 PM.
- Store hours are posted and may change at our discretion.
- Basketball, volleyball, horseshoes, Cornhole, and other games are available for check-out. Please use the sign-out sheet at the store.
- A dumpster is located across from the store and shall only be used for household waste accumulated from within the campground. No bulky items or hazardous waste.
- Please accompany your children 6 years old or younger while they are enjoying the campground.
- All children under the age of 14 must wear an approved bicycle helmet per New York State Law. Riding allowed from dawn to dusk.
- Two cars are allowed per site, all others must park in an area designated by the office at check-in.
- All alcohol must be consumed responsibly. If there are any concerns with disorderly conduct or drunkenness, all parties connected will be required to leave without a refund.
- The pond is for fishing (catch and release only), no swimming or boats are allowed.
- No firearms, fireworks or illegal drugs are allowed on the campground property.
- No electric heaters, refrigerators, or freezers are to be used without the permission of the owners.
- Tent sites Maximum of 2 adults and three children. 1 tent per site. A second tent will be allowed for children under 18 years old.
- RV sites 2 Adults and 3 children under the age of 18. Only 1 tent is allowed on an RV site and only for children under 18 years old.

Visitors

• Visitor daily fees 9:00 AM to 10:00 PM \$5.00 per person. Overnight fees \$15.00 per person. (Children under 5 free). Maximum day visitors of 2 adults, 3 children or 4 adults and a maximum of 2 overnight visitors. All visitors shall register at the camp store and pay the visitor's fee before going to a campsite. Registered site occupants are fully responsible and liable for the actions of all their visitors. No Visitors shall enter the campground before 9:00 AM or after 7:00 PM. Visitors may not bring any animals into the campground.

Pets

• You must provide a valid rabies certificate at check-in for each dog. Maximum of 3 dogs. Barking dogs will not be tolerated. Dogs must be on a 6' maximum leash and accompanied by an adult at all times. No dogs are allowed in the store, Rec Hall or pool area. Dog(s) shall not be left unattended at any time in the campground. Nuisance dogs will be asked to leave. You must clean up after your pets.

Firewood / Propane

- Hide-a-Way Campsites follows DEC rules regarding transportation of firewood. Firewood can only be brought into the campground if it
 originates within a 50-mile radius and you are not crossing state lines. No Ash firewood permitted. You must also have a DEC transport
 permit filled out upon arrival, a copy of which will be made in the office. Transport permits are available on the DEC website. Any
 firewood brought in which is not within the above guidelines shall be removed immediately from the grounds.
- Firewood, fire starters and propane are available for purchase in the store.
- · Cutting, chopping or burning of campground trees or vegetation, dead or alive, is not permitted.
- Campfires must be extinguished before leave your site or before returning to your camper for the night.

Pool

- NO LIFEGUARD ON DUTY. SWIM AT YOUR OWN RISK. NO DIVING ALLOWED.
- Pool hours are 10:00 AM to 7:00 PM. No food, alcohol or glass containers are allowed in the pool area.
- **NY State Law:** All campers and their guests must sign a waiver at the camp store before using the pool; then use the daily sign-in sheet for each use, posted at the pool entrance gate.
- The pool will be closed at the management's discretion during inclement weather or emergencies.
- Never swim alone. A minimum of (2) CAPABLE adults, 18 years of age or older must be present whenever the swimming facility is in use, with at least (1) CAPABLE adult on the pool deck at all times. There is no substitute for adequate supervision. Children under 18 years of age must be accompanied to the pool by a CAPABLE parent or guardian responsible for their safety and behavior.

In an emergency, notify the office or an employee immediately. If you are unable to contact an employee, seek help at the owner home across from the store.
